Maurice E. and Ella I. Heath; bounded as described as follows:-Easterly by Portland St. so called, southerly, by a lot of land now or formerly owned by Elizabeth Trumbull, the southerly boundary line being of a length of (147) feet and bearing a course of North (72) degrees West (when taken)- from said Portland Street; Westerly by land now believed to be owned by Fred R. Sanborn, formerly owned by Heirs of Charles B. Gibbs; Northerly by a lot of land now owned by Charles E. Bertwell, a part of the Charles H. Chase premises formerly. Also another parcel of land adjoining and adjacent to the above mention parcel deed dated May 20, 1921 in BOOK 1078, PAGE 4. bounded and described as follows:-Commence at the southeasterly corner of the homestead lot of said Elisha S. Heath on the westerly side of said street, thence run north about (72) degrees West and by the southerly line of said Heath's land to the southwesterly corner thereof about (147) feet; thence South (18) degrees West (35) feet to an iron stake set in the ground; thence South (72) degrees East and parallel with the aforesaid southerly line of said Heath lot to the aforesaid street, and thence northerly by said street (35) ft. more or less to the point thereon begun at.
