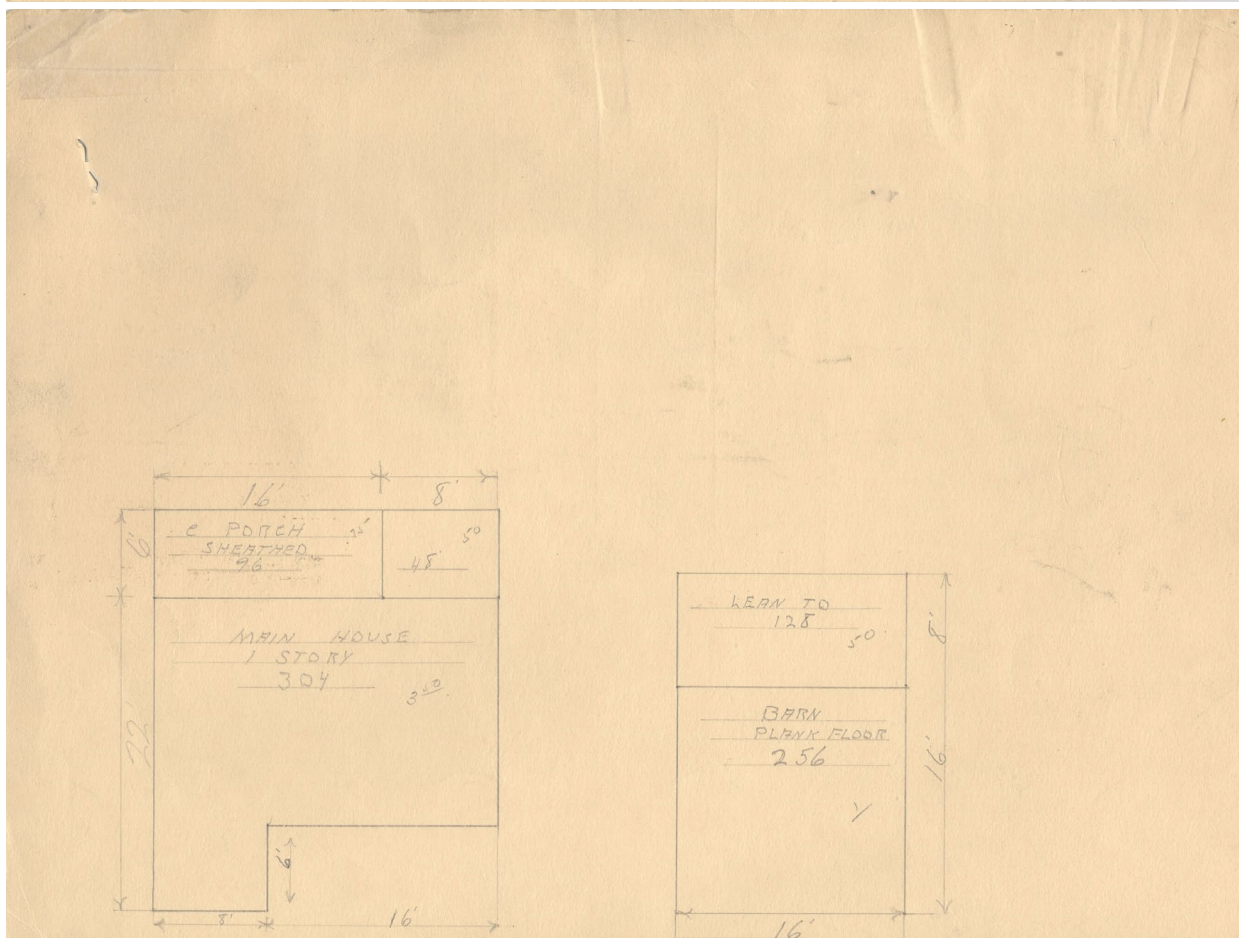
DESCRIPTION OF PROPERTY

John E. Weeman bounded and described as follows:-Commencing at a point on the westerly side of said Portland St. and (130) feet southerly of the southerly line of land of Flora Flint, thence in a westerly direction on a line at right angles with the cement side walk on said Portland Street (125) feet to a point; thence in a southerly direction on a line parallel with said cement sidewalk (60) feet to a point; thence easterly on a line parallel with the first described course and at right angles with said cement sidewalk (125) feet to said sidewalk; thence northerly along the line of said Portland Street to the point of commencement.
