

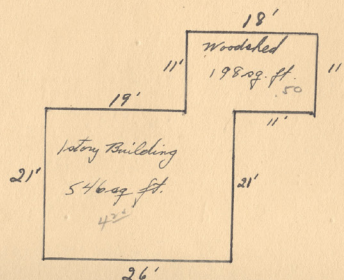

DESCRIPTION OF PROPERTY Mortgage Deed . BOOK 1375- PAGE 78- June 1, 1931

1 Story, Good Condition. Ella M. Garland to S. Minot Lord. A certain lot or parcel of land with the buildings thereon situate in said Bridgton and in Bridgton Center Village and on Bennett Street so called and being my present homestead premises and the same conveyed to me by J. Bennett Pike, administrator of the estate of Charles M. Allen by his deed dated October 24, 1929 and recorded in Cumberland Registry of Deeds, Book 1328, Page 409, and bounded as follows:--- Northerly by road leading from Bennett Street to dwelling house of Owen Powers; Easterly by Bennett Street; Southerly by house lot supposed to be owned by Kate Buckley and Westerly by land supposed to be owned by Charles Maxfield. Assignment of Mortgage to S. Minot Lord to Frank A. Webb.
