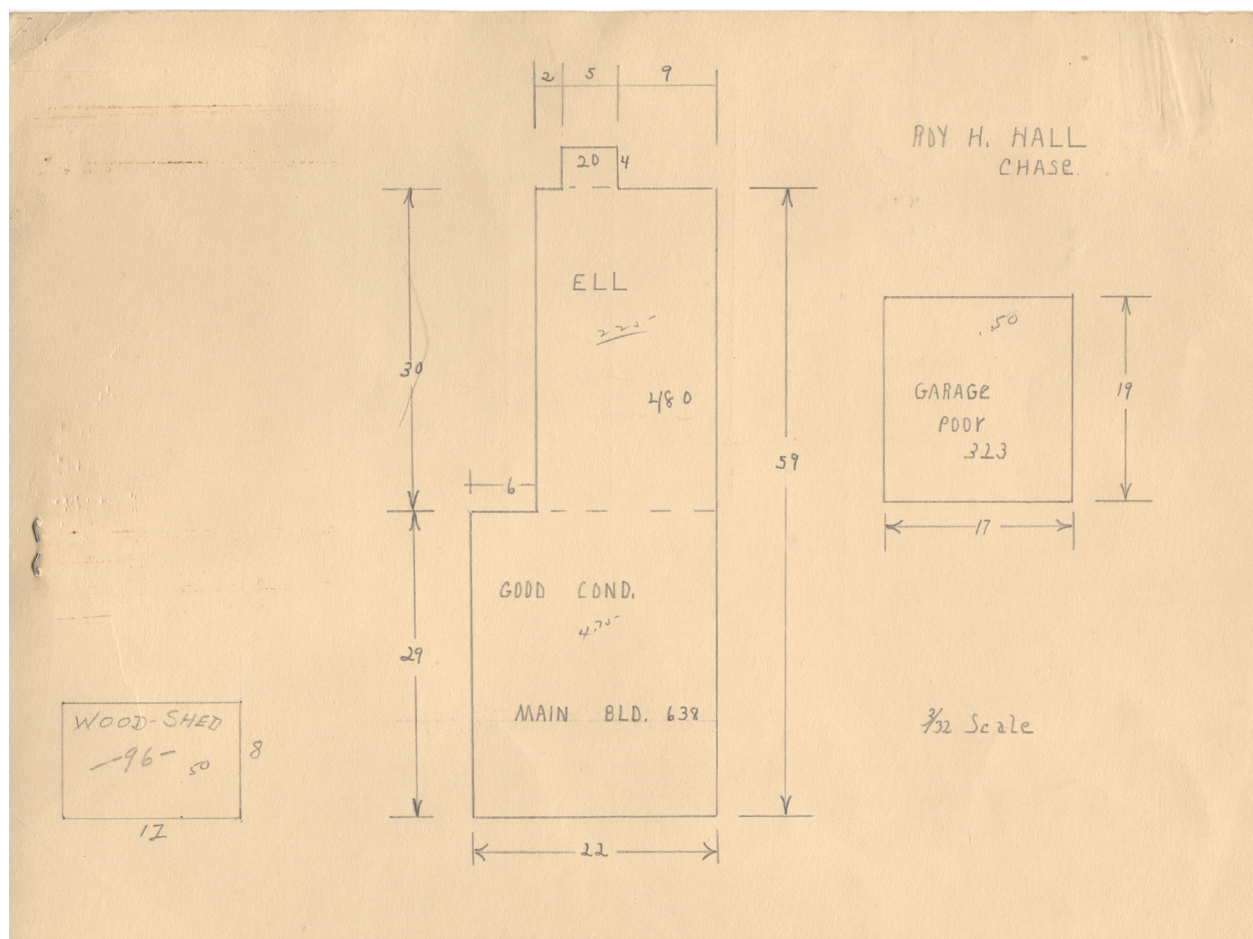

1 1/2 story fair condition. Garage poor condition.

Roy H. Hall:--Commence on the westerly side of Chase Street, in said village, at the north-easterly corner thereon of the homestead lot of Addie P. Ames, formerly land of Richard Gage; thence run westerly by said Ames-Gage land about ten rods to land of the heirs of Isaac Webb, and a stone wall; thence northerly and by said last named land and wall five rods; thence northeasterly about eight rods to a stake and stones on Bennett Street (formerly called the Allen road); thence by said Bennett Street in an Easterly to South-easterly direction about three rods to said Chase St; and thence Southerly by said Chase Street to the point thereon begun at.
