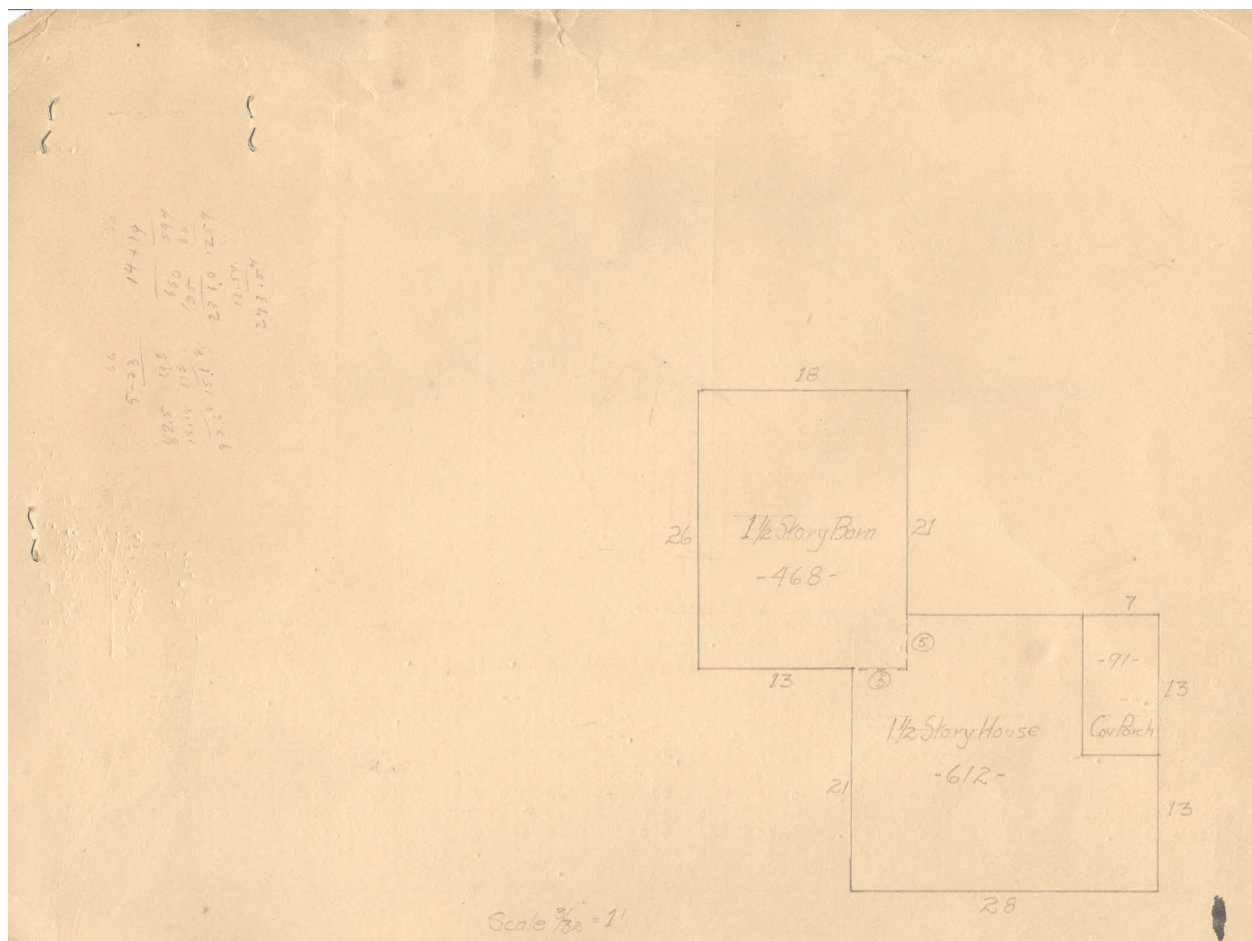

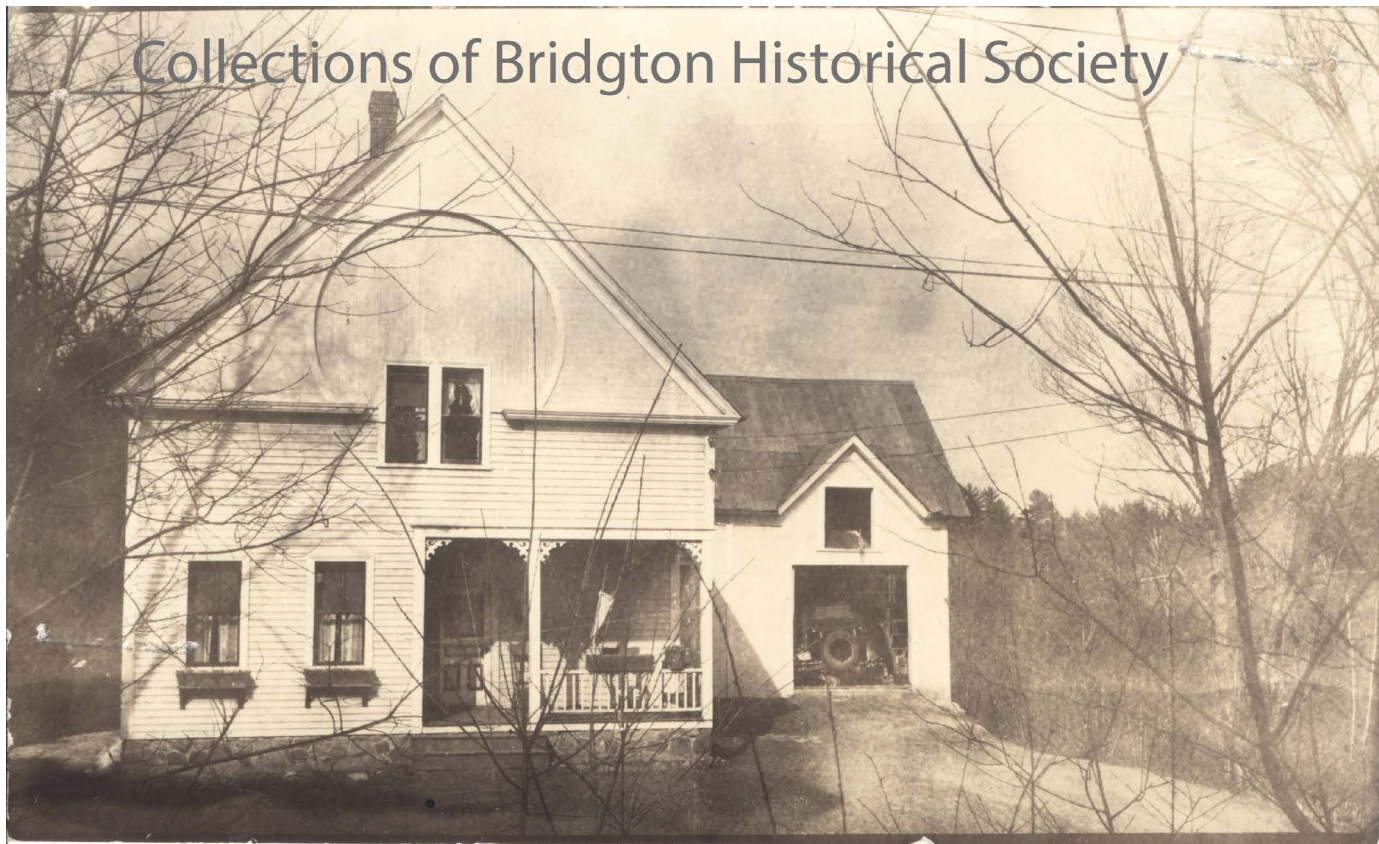

DESCRIPTION OF PROPERTY 1 1/2 Story, Fair Condition.
This description was taken from a bond for a deed by Joshua F. Bennett.
A certain lot or parcel of land situate in said town of Bridgton in the County of Cumberland and State of Maine--- and on the Easterly side of Bennett Street therein-- bounded as follows, to wit---
Commence on said side of said street and at an elm tree standing thereon, at or near to the northwesterly corner of the tenement house lot of the said Bennett.-- thence run North sixty-three degrees and thirty minutes east--- fourteen rods and nineteen links,-- measured from said tree to an iron pipe corner; thence northerly and parallel with Bennett Street (N 25 degrees --- 10 minutes W) five rods and twenty-three links to an iron pipe corner; thence South sixty-three degrees and thirty minutes West parallel with the first course run; to said Bennett Street and thence Easterly by said Street five rods and twenty-three links, to the point begun at. ~~Also~~ right to use in common for a drive way this strip of land lying between the lot above described and homestead of Samantha H. Bennett for a distance of forty - five (45) feet extending easterly from said Bennett Street.
