I rec^d your letter last evening am sorry to learn that you have not rec^d your money due at Fredericton I also regret that the British are so foolish as to pretend to hold the Country they do --- there will be a great effort to adjust the difficulty the present season. M. Gallatin has it in charge. We as agents are justified by our Government in what we have done. I wish you to scrape together all the account of timber logs &c which you have any evidence the British have cut out any time and keep a constant and exact copy of the same and forward to me. I am satisfied we shall have a claim on your Neighbors in a short time you will continue to do all you can to prevent trespassers and to help the settlement I do not expect to let out any lands in your quarter this year -- you will not fail in the Close of the season to make your return complete, Maine & Massachusetts will probably layout \$2000 this season on the Holton road -- You will have heard many things concerning trespassers on the Penobscot, it is bad enough, it is in vain for me
