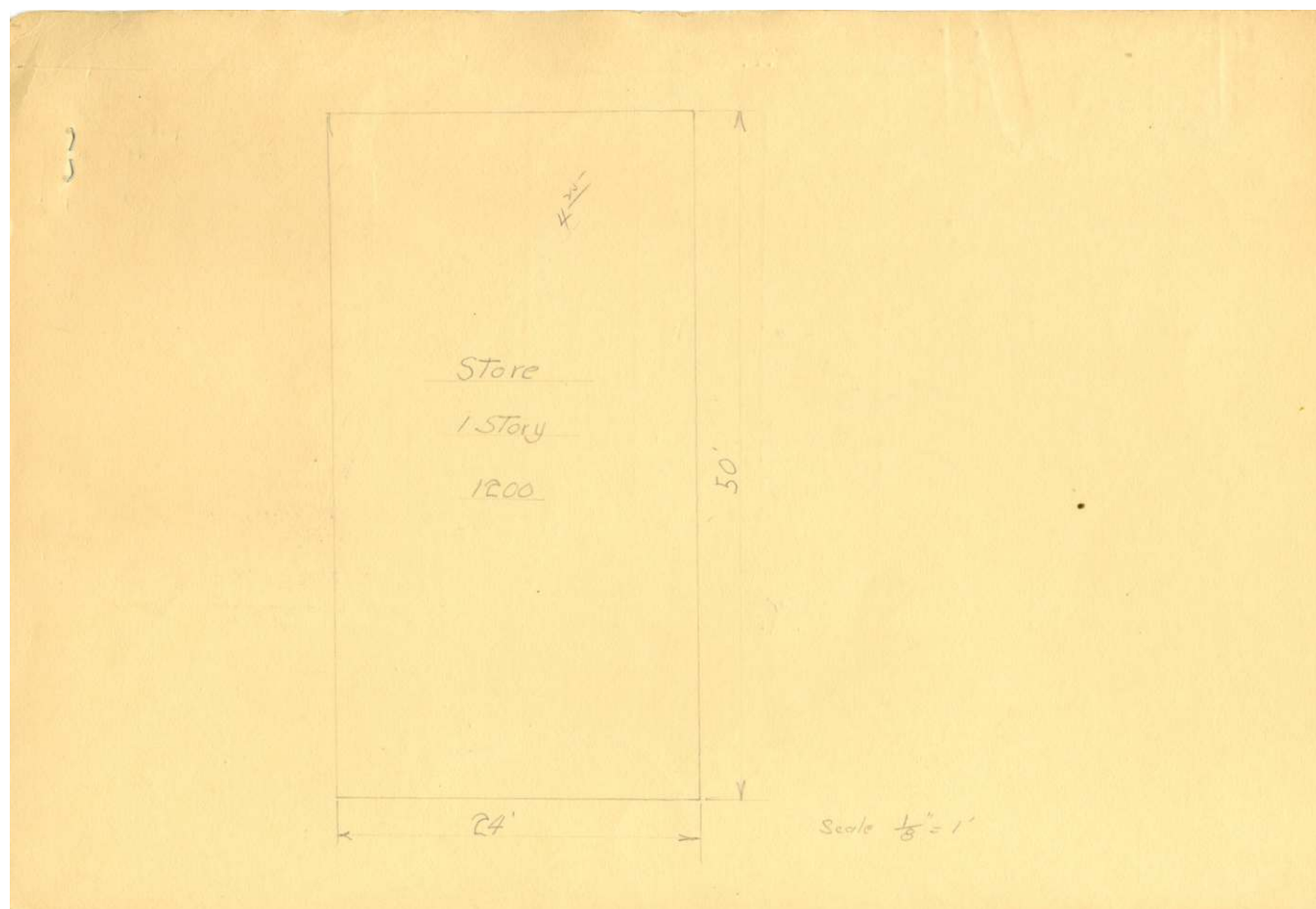

DESCRIPTION OF PROPERTY Jun. 6, 1927 BOOK 1078 PAGE 183

Eugene and Lizzie Tenney; bounded as follows:- Commencing on the northerly side line of Main St. at its intersection with the westerly side line of Elm Street; thence Westerly by said Main Street to the Walker Ditch, so called, to land now or formerly owned by W. E. Crosby; thence Northerly by said Crosby land to land conveyed to M. Rose Giles by Milched B. Burnham by deed dated June 19th 1913 and recorded in Cum. Reg. of Deeds BOOK 915 PAGE 164 thence Easterly by said Giles lot to said Elm Street; thence Southerly by said Elm Street to Main St. at the point of beginning (10 feet sold to E. H. Smith for a driveway) (not in recorded deed)
