Eugene Chaplin, thence run westerly on the northerly line of said Chaplin premises and Church Lot of Methodist Episcopal Church to homestead premises of E. A. Littlefield; thence northerly on easterly line of said Littlefield premises to land of A. Geneva Maxfield; thence easterly by said Maxfield land and house lot of Roy Hall to said Street, and thence by said Street southerly one hundred and fifty (150) feet more or less to the point of beginning.</p>	1503	36	July 18, 1936
