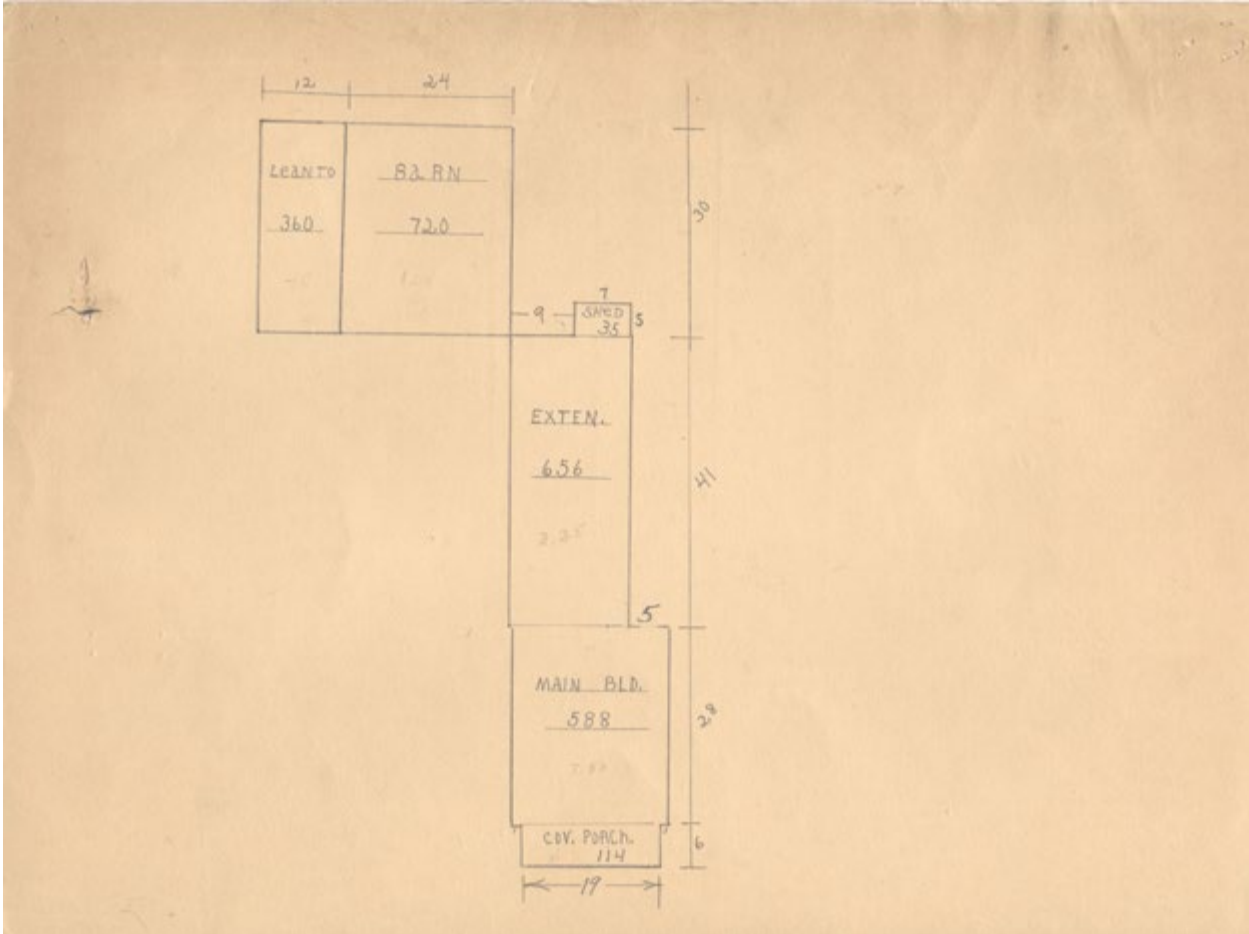

**DESCRIPTION OF PROPERTY**  
 Good condition.
