



Whereas at a legal Town Meeting held at Cary's Hall in Houlton on the 17th day of August A.D. 1863, it was voted to pay men drafted under the Conscription Act, who should go themselves, the sum of three hundred dollars each, and was also voted to pay drafted men who should furnish substitutes such sums as they should pay therefor not exceeding three hundred dollars each: and whereas having been drafted and having furnished a substitute to whom I paid the sum of three hundred dollars, I am by the conditions of said vote entitled to said sum of three hundred dollars to be paid me by the Town of Houlton with interest:

Now be it known that in consideration of the sum of three hundred dollars to me paid by John H. Bradford of said Houlton, I do hereby sell assign & transfer to said Bradford the above named claim against the Town of Houlton and all my right title & interest in & to the same.
