

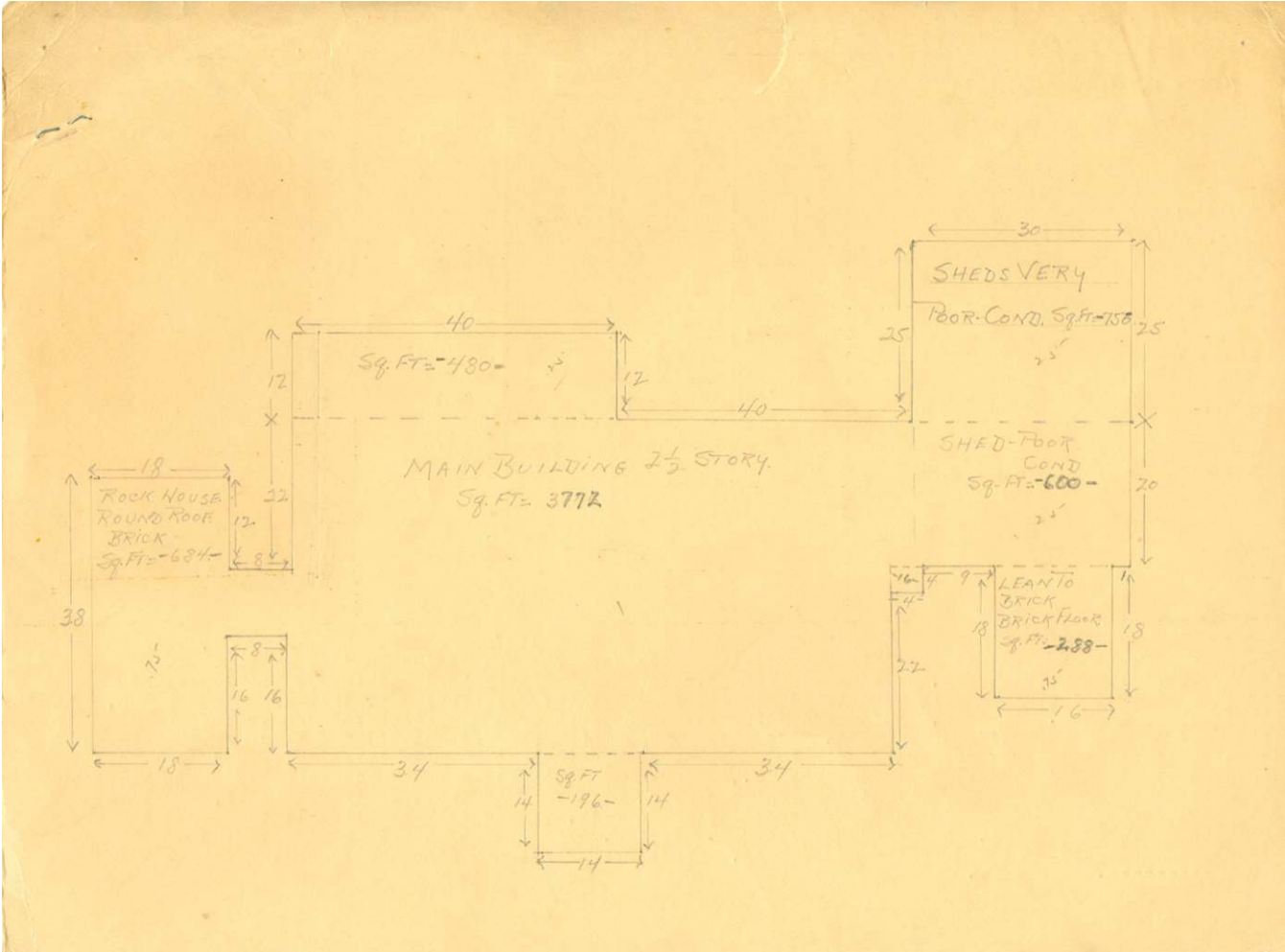

DESCRIPTION OF PROPERTY BOOK 1417 PAGE 378 May 11, 1933

Also another lot of land with buildings thereon namely the Old Post Office Building; and on the northerly side of Main Street, bounded as follows:--Begin at a stone post set in the ground on the northeasterly side of said Main Street and nearly opposite the residence formerly of Rufus Gibbs, now owned by John A. Morrison, said part being about one foot from the southwest corner of the Old Post Office Building (said building being on the premises now being described) and which said post is also the southeasterly corner of the Mill Lot known as Pondicherry Mill #2 and being the Mill Lot conveyed by Rufus Gibbs to the Pondicherry Co., thence run North about 32 degrees east by said Mill lot #90 feet to the south bank of the Mill Place so called, thence south about 63 degrees east, parallel with northerly end of said Old Post Office Buildings 44 feet, to the westerly side-line of the Old Bridgton Savings Bank lot, now owned by Sumner O. Newcomb, thence south about 33 degrees and 30 minutes west by said mentioned lot on said Main Street, thence westerly by said Main Street 44 1/2 feet to bound first mentioned. begun at.
