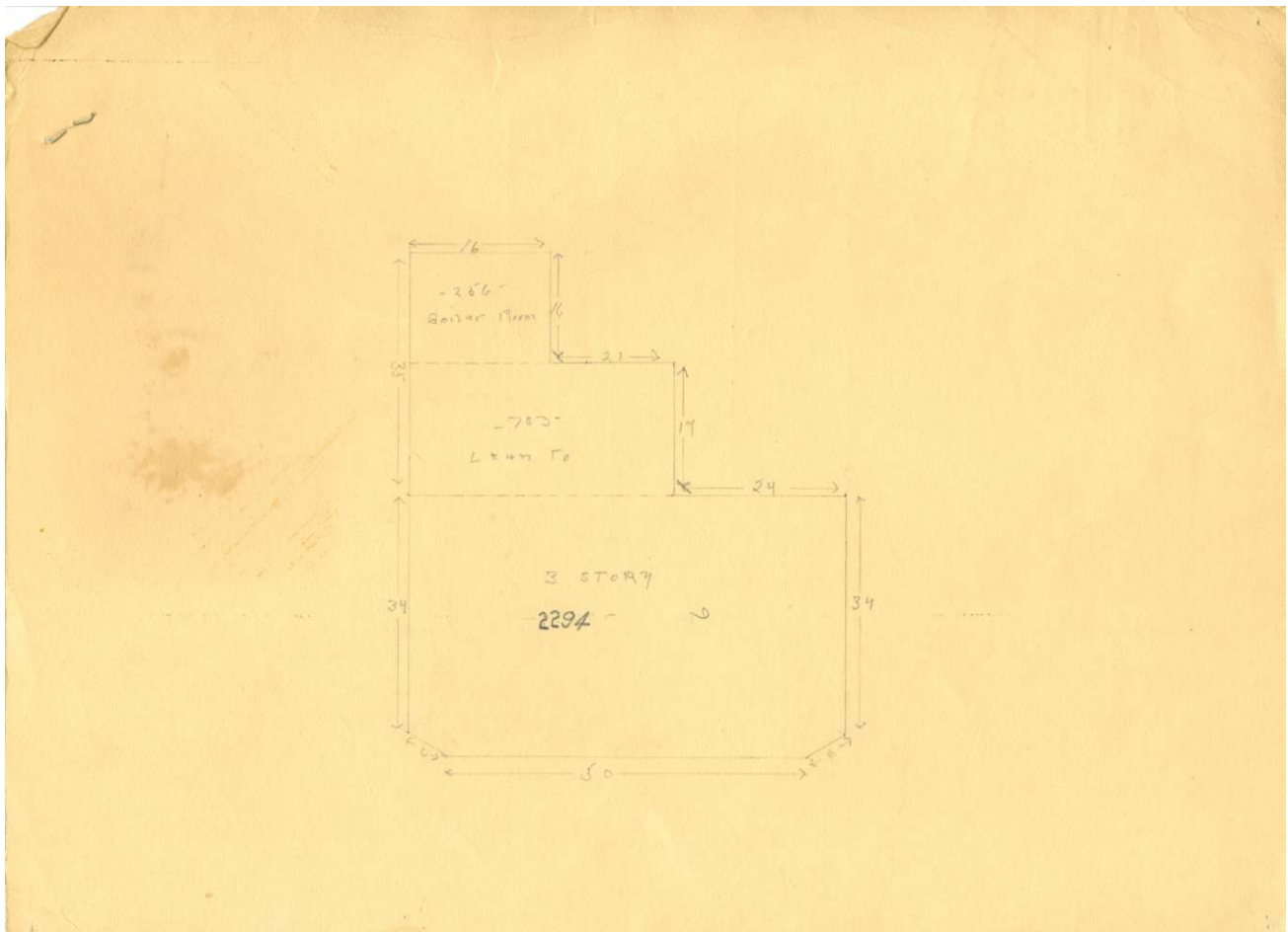

DESCRIPTION OF PROPERTY May 14, 1906 **BOOK 788** **PAGE 143**
 K. of P. Block-Highland Lodge No. 10. Knights of Pythias; described as follows:-Commencing at the northwesterly corner of the late George G. Wight homestead on the Southerly side of Main St. run Southerly on the line of said homestead to Meadow Brook, so called; thence Westerly at a right angle to said last line to Depot Street, so called thence Northerly on said last named street to said Main St. an thence Easterly on said Main St. to the place of commencement.
 Also one-half part in common and undivided of another parcel adjoining the above described lot and bounded as follows:-commencing on the Southerly side of Main St. at a point (B) east Westerly of the Northwesterly corner of the so called Wight office building run Southerly at right angles with said street till such course shall strike the Easterly line of land of said Staples had by him of Elizabeth G. Billings (meaning the first above mentioned parcel thence Northerly on said Easterly line of said Street and thence Easterly on said street to the place of commencement.
