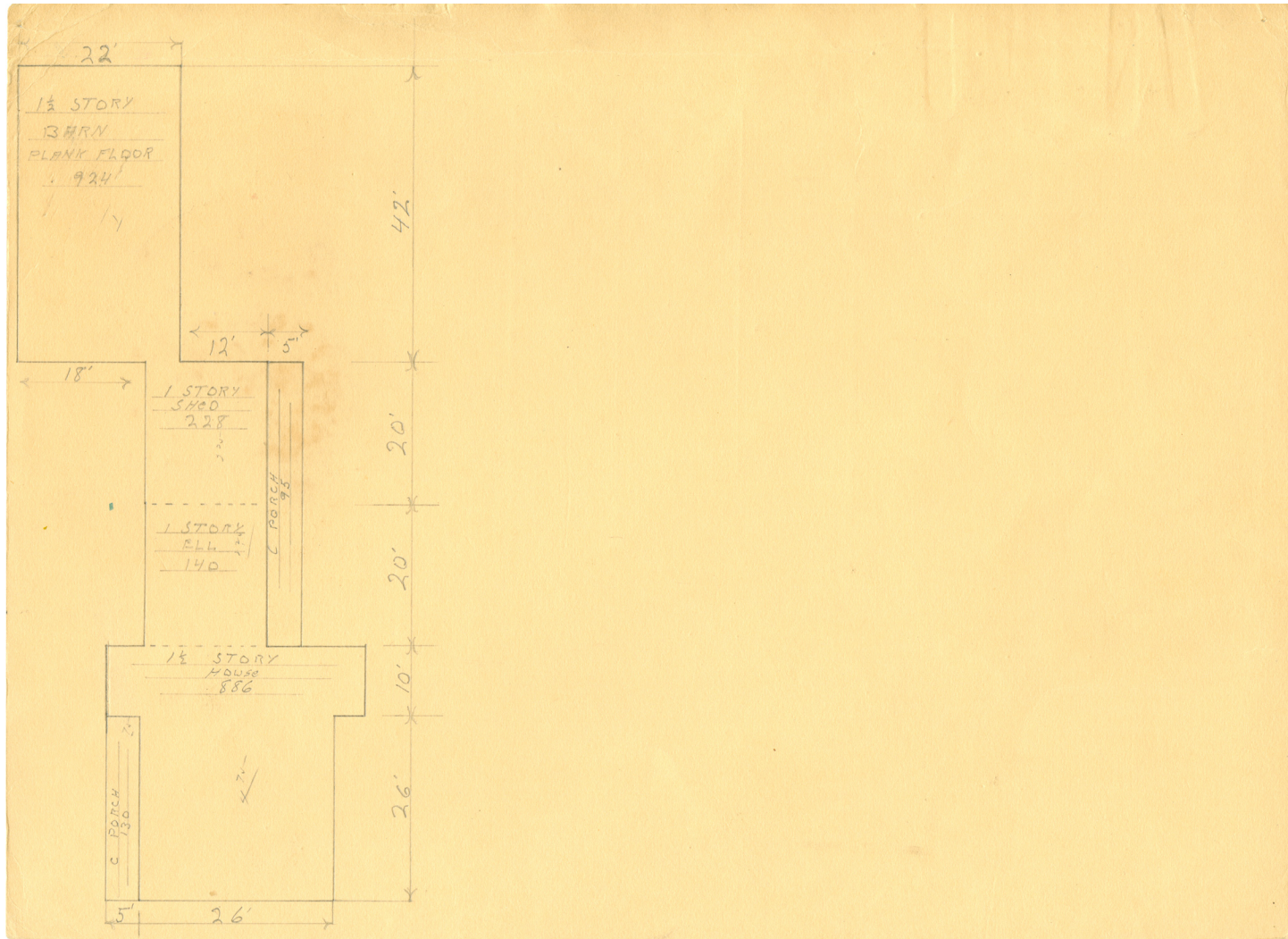

**DESCRIPTION OF PROPERTY**  
 Sept. 16, 1931 BOOK *1384* PAGE *177*  
 95 Main St. Amy I. Tanson; Commence on the southerly side of said Main St. and at the north-westerly corner thereon of the David M. Scribner homestead lot, owned by him at time of his decease; thence run southerly, and by the Westerly side-line of said Scribner lot, to Steven Brook; thence Northwesterly by and up said brook to the southeasterly corner of the Methodist parsonage lot; thence northerly, and by said last named lot, to an iron pipe corner on the easterly line of said parsonage lot and at the southwesterly corner of homestead lot formerly owned by Agnes M. Sanborn; thence easterly by the southerly line of said Sanborn lot, the course thereof bearing South (71) degrees and (30') East, in 1919, (53 1/2) feet, to an iron pipe corner at the Southeasterly corner of said Sanborn lot; thence North (18 1/2) degrees East, in 1919, by the easterly side line of said Sanborn lot, to said Main St. and thence easterly by said Main St. to the point and bound begun at.
