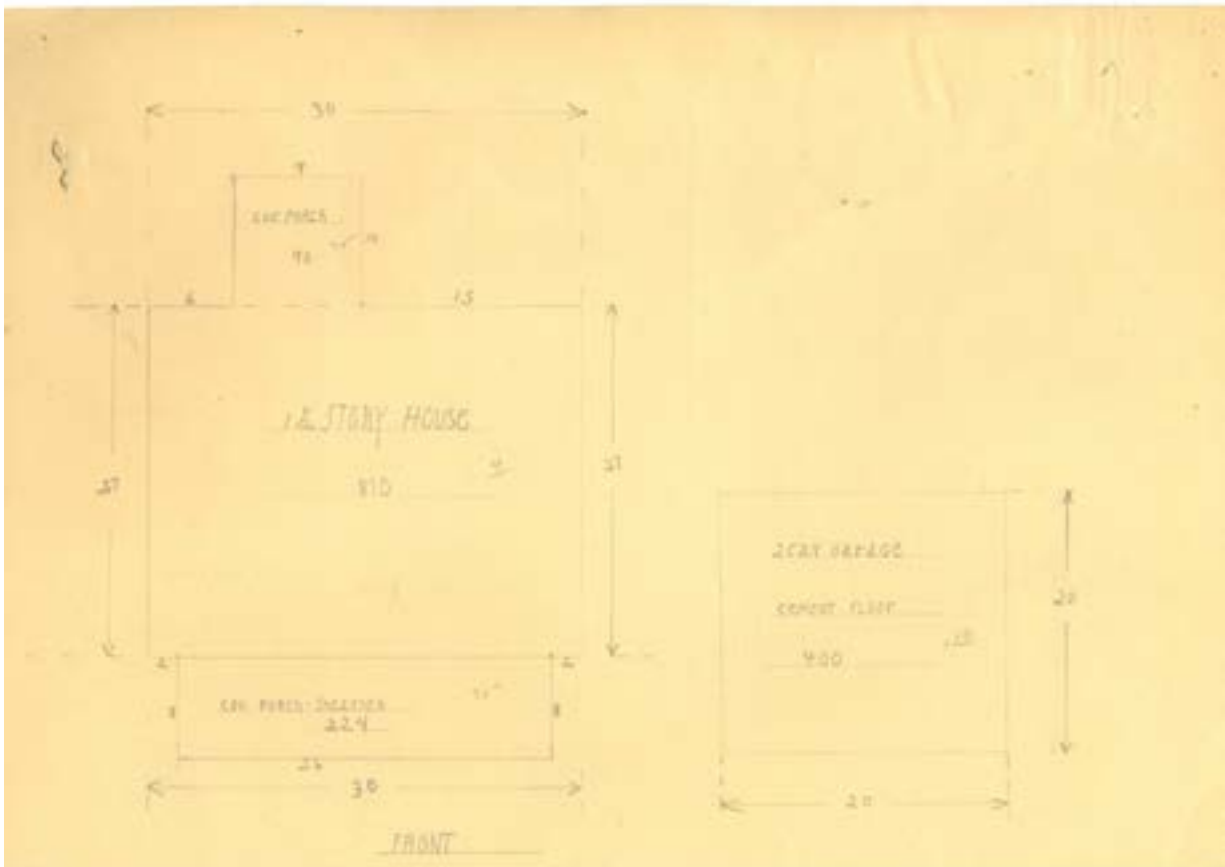

**DESCRIPTION OF PROPERTY**

BOOK 1447 PAGE 48 June 15, 1934

A lot or parcel of land with the buildings thereon situated on the west side of Portland Street, so called. Commence on the westerly side of said Street, and at the northeasterly corner thereof of the Homestead Premises occupied by Elisa S. Heath, an iron pipe; thence run northerly by said street, 100 feet to an iron pipe; thence westerly and parallel with the northerly side line of said Heath premises, 126 feet to an iron pipe corner; thence south about 84 degrees and 30 minutes west, 100 feet to an iron pipe driven on said northerly line of said Heath Premises; and thence easterly by said northerly line of said last named premises to said street and bound thereon begin at.
